## Development update

## Keeping you updated

We wanted to provide you with an update on the development and what you can expect from us over the coming months.

### Overview

- 345 new build properties across the development.
- 5 attenuation basins, adding and expanding on existing ponds.
- New releases have photovoltaic panels.
- Play area and neighbouring recreation ground.

### Site activity

- Recently completed on the 160<sup>th</sup> occupation of the development.
- Following consultation with Lancashire County Council the proposed spine road retaining wall works have a potential August-September 2025 start date.
- Highway improvement works to Lytham Road (A584) agreed with Lancashire County Council, planned to commence August 2025.
- **NHBC Pride in the Job award winner 2024.**

## Drainage

- The surface water discharges into the rerouted open watercourse, which runs parallel to the spine road and connects into the existing surface water network.
- Foul water discharges into the existing United Utilities network via the on-site pump station, which is to be adopted by IWNL (Independent Water Network Limited).

## Timeline

- Additional works to be completed to the retaining wall on Nectar Drive in the spring/summer months, as approved by Lancashire County Council (Highways Authority).
- The above-mentioned works will be coordinated to give as little disruption to residents as possible, with dates to be confirmed via a letter drop.
- Area of POS on Nectar Drive is to be stripped back to allow the above-mentioned works to take place. Following completion, the area will be made good in line with the approved landscaping scheme and handed over to TrustGreen for adoption and maintenance.
- Highway improvement works to Lytham Road, to provide a toucan crossing for pedestrians and bicycles as well as extending the 30mph limit in line with LCC requirements, has been approved and agreed to commence in August 2025. These works will also be coordinated to give as little disruption to residents as possible, with dates to be confirmed via a letter drop.

## Managing agent

- TrustGreen have been appointed on behalf of Countryside Partnerships to maintain the soft landscaped/POS areas of the Beaumont Green development.
- First 2no. attenuation basin/POS areas have been adopted by TrustGreen.

## Ecology

- Upcoming properties will have hedgehog fence gaps, whilst certain plots will be fitted with bat, swallow, house martin and swift boxes – where specified.
- The development will also have hedgehog and nest boxes, as well as brush piles in the enhanced woodland area (located where the compound is currently situated along the Northern boundary).
